Nanuka Zhorzholiani Wife of the Head of the Criminal Police Department within MIA Irakli Kodua	Works for the TV-Radio Company Imedi and is anchor of the TV-program Nanuka’s Show both at the Imedi-TV and Imedi-Radio. Her income is not clarified in the declaration; the document provides information only about 2004 income of Irakli Kodua
Lela Kiladze Wife of the Tbilisi City Mayor Gigi Ugulava	Producer of the entertainment program “Bravo” at the TV-Company Rustavi 2. The 2010 declaration of the Mayor does not provide information about his wife’s income
Yana Framer Wife of the Georgia’s Ambassador to the USA Temur Iakobashvili	Works at the Georgian Public Broadcasting as a chief producer of the First Caucasian Channel. Her annual income was 9 316, 9 GEL. She owns land (260 sq. meter) in Vertskhli Street # 39, Tbilisi; she has 2 000 GEL on her salary account in the Standard Bank

<p>Rusudan Nikolaishvili Wife of the Minister of Regional Development and Infrastructure Ramaz Nikolaishvili</p>	<p>According to the declaration, she is unemployed. She owns neither property nor bank account. Ramaz Nikolaishvili is the owner of the family income and property.</p>

She has a flat (30 sq. meters) in Vazha Pshavela Avenue, flat (50% of 70 sq. meters) in Saburtalo Street, non-residential space (50% in 14 sq. meters) in Agladze Street; a flat (60 sq. meters) in Agladze street, car Mitsubishi (2008). She has 3 000 GEL on her salary account in the TBC Bank
